- 2. Elaborate on the notion of 'History' in early India? How is this different from the modern notions of the discipline?
- 3. Critically comment on the 'urban revolution' hypothesis in medieval northern India in the light of recent writings.
- 4. Periodization is a construct that has only limited relevance. Discuss the statement in relation to the question of 'medieval' in Indian history.
- 5. What are the parameters of "modernity" and "tradition"? How did these concepts feed into indigenous identities taking shape under the influence of western ideas and colonial policies?
- 6. What is a 'mass' movement? Critically analyse the Gandhian position on the participation of the masses in the national movement.

- 5. How did the bhakti saints subvert the dominant order and to what extent were they successful.
- 6. Discuss the religious policy of Akbar.
- 7. Why did the colonial government develop electoral politics? Which communities were targeted and why? How did these communities begin to articulate their political demands?
- 8. What were the ideologies deployed by the colonial government in order to control India? Critically develop two such ideologies by which the British justified their rule in India.
